How to Leave a Bequest in Your Will

Thank you for your continued interest in supporting young people at-risk to transform their lives. Leaving a gift in your will is both simple and versatile. Below are the types of gift you can offer in a bequest:

A Residuary Bequest:

A residuary is a gift given to Human Nature Adventure Therapy, after your family and any other beneficiaries have been taken care of. Suggested wording:

I give, free of all duties and taxes, the residue of my estate (or ____% of the residue my estate), to Human Nature Adventure Therapy Ltd. ABN 47 609 965 282, of Office 1, 108 Stuart Street, Mullumbimby, NSW 2482, to be used for its general purposes. The official receipt of the organisation shall be a full and sufficient discharge to my executor(s)/trustee(s).

A Percentage of Your Estate:

This involves leaving a specified percentage of your estate, or perhaps a whole estate if you have something specific in mind, to Human Nature Adventure Therapy. It is relatively simple, and protects against inflation. Suggested wording:

I give, free of all duties and taxes, ____% of my estate (or the whole of my estate), to Human Nature Adventure Therapy Ltd. ABN 47 609 965 282, of Office 1, 108 Stuart Street, Mullumbimby, NSW 2482, to be used for its general purposes. The official receipt of the organisation shall be a full and sufficient discharge to my executor(s)/trustee(s).

A Pecuniary Bequest:

This involves leaving a specified sum of money to Human Nature Adventure Therapy. Suggested wording:

I give, free of all duties and taxes, the sum of \$____, to Human Nature Adventure Therapy Ltd. ABN 47 609 965 282, of Office 1, 108 Stuart Street, Mullumbimby, NSW 2482 to be used for its general purposes. The official receipt of the organisation shall be a full and sufficient discharge to my executor(s)/trustee(s).

A Specific Bequest:
